By The Commission:

A hearing in the above-entitled matter is set for **Thursday, March 26, 2009.**

Generally, the purpose of this hearing is to receive testimony regarding Questar Gas Company's (Questar) proposed changes to demand side management (DSM) programs and the market transformation initiative, along with Questar's proposed third-year budget for these programs. Specifically, matters to be discussed will relate to the ThermWise Weatherization Rebates Program and ThermWise Multifamily Rebates Program, including: 1) increases in the rebate program budget to allow for increased on-site verification of contractor work; 2) increase in budget to allow for greater capacity for rebate processing, program management, and trade ally relationship management; and 3) changes in attic, floor, and wall insulation credits. Questar seeks implementation of these changes effective April 1, 2009. It suggests the proposed changes will help ensure cost-effective programs that benefit all GS customers.

The hearing will be conducted by the Administrative Law Judge of the Public Service Commission of Utah on **Thursday, March 26, 2009 beginning at 11:00 a.m. and continuing to 1:00 p.m. A portion of the time scheduled from 11:00 a.m. to 1:00 p.m. will be reserved for public witness testimony. Additionally, public witness testimony will be heard that same day from 4:30 p.m. to 5:30 p.m.**
