Pursuant to Utah Admin. Code R746-100-3(H) and Utah Code § 63G-4-201, Questar Gas Company (the “Company” or “Questar Gas”) requests that the time for responding to memoranda filed by both the Division of Public Utilities (Division) and the Office of Consumer Services (Office) be extended until September 30, 2011. In support of this request, the Company states as follows.

1. On June 6, 2011, Questar Gas submitted its Integrated Resource Plan for the Plan Year of June 1, 2011 to May 31, 2012.
2. On June 21, 2011, the Utah Public Service Commission (Commission) issued an Action Request in the matter, and on August 2, 2011 the Commission issued an Order Granting Extension of Time allowing the Division additional time to file its report in the docket.

3. On August 25, 2011, the Division and the Office both filed comments in this Docket.

4. Questar Gas seeks this extension of time to file responses to the comments referenced above because those comments raised a number of issues and Questar Gas has not yet completed its review of those issues. Questar Gas respectfully seeks additional time in which to fully review the issues raised in those comments and to determine what response, if any, is appropriate.

Therefore, Questar Gas respectfully requests an extension of time until September 30, 2011 to file responsive pleadings in this matter.
