Questar Gas Company (Questar Gas) respectfully submits this Late Filed QGC Exhibit 3.0 pursuant to the request of the Utah Public Service Commission (Commission). During the January 30, 2013 hearing on this matter, the Commission requested that Questar Gas submit a set of the Guideline Letters referenced in Section V-15 of the Wexpro II Agreement (Questar Gas Exhibit 1.4). Accordingly, Questar Gas has attached as QGC Exhibit 3.0, a set of the referenced Guideline Letters.

Because the data contained in the Guideline Letters is sensitive, proprietary and confidential in nature, Questar Gas respectfully requests that they be maintained as Confidential pursuant to Utah Admin. Code § R746-100-16. The Guideline Letters contain sensitive and proprietary operational information, proprietary information about geological formations and

zones, information about private lease agreements, confidential accounting practices and confidential information related to third parties with interests in certain wells. Disclosure of the information contained in the Guideline Letters could reasonably be expected to result in unfair competitive injury or commercial injury to Wexpro and to the third parties referenced in the Guideline Letters. Disclosure would also impair Wexpro's ability to conduct business with third parties in the future because such parties would be concerned that information of this nature would become public. Therefore, Questar Gas requests that the Commission maintain QGC Exhibit 3.0 as confidential pursuant to the applicable regulations. Accordingly, Questar Gas has marked QGC Exhibit 3.0 "CONFIDENTIAL – SUBJECT TO UTAH PUBLIC SERVICE COMMISSION RULE 746-100-16" and has submitted it on yellow paper.

For the reasons stated above, the Guideline Letters are also subject to confidential treatment under Utah Code Ann. § 63G-2-305, the Government Records Access and Management Act.

Based upon the foregoing, Questar Gas respectfully requests that the Commission receive QGC Exhibit 3.0 into evidence and maintain it as confidential pursuant to Utah Admin. Code § R746-100-16 and Utah Code Ann. § 63G-2-305.0
