In particular, they shall adequately explain: “Explicit and detailed sources of the information contained in the exhibit; methods used in statistical compilations, including explanations and justifications; assumptions, estimates and judgments, together with the bases, justifications and results; formulas or algorithms used for calculations, together with explanations of inputs or variables used in the calculations.” Parties shall serve copies of all filings on other parties by electronic mail at or before the time an electronic copy of the document is required to be filed with the Commission.

NOTICE OF PUBLIC HEARING

The Public Service Commission gives notice that it will conduct a public hearing in the above-entitled matter on **Wednesday, August 7, 2013, beginning at 9:00 a.m. (MDT) and Thursday, August 8, 2013, beginning at 1:00 p.m. (MDT)**.
