NOTICE OF APPLICATION TO INCREASE RATES

Pursuant to Utah Code Ann. § 63G-4-201 et seq., notice is given that Questar Gas Company (“Questar”) filed the above application on May 2, 2013. If approved by the Public Service Commission, typical residential customers using 80 decatherms per year will see an increase in their total annual bill of \$47.39 (or 7.08%), or \$3.65 monthly.

NOTICE OF COMMENT PERIOD

Any interested party may submit comments on the above application within 15 days following this notice, and reply comments may be submitted within 25 days following this notice.

NOTICE OF HEARING

Notice is given that a hearing in the above-entitled matter will be conducted by the Administrative Law Judge of the Public Service Commission on **Wednesday, May 29, 2013, beginning at 1:00 p.m. (MDT)**.
