**PETITION TO INTERVENE

Pursuant to Utah Code Ann. § 63G-4-207 and Utah Admin. Code § R746-100-7, Nucor Steel, a Division of Nucor Corporation (“Nucor”) hereby moves for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah. In support of this Motion, Nucor states as follows:

1. On July 1, 2013, Questar filed an application with the Commission for an order authorizing an increase in its distribution rates and charges for natural gas service.
2. Nucor owns and operates a steel mill in Plymouth, Utah, and takes gas transportation service from Questar. Nucor’s full name and primary place of business is:
