Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Petitioner Emery County Economic Development Department (“EMERY”) hereby petitions for leave to intervene in this docket.

In support of this petition, Petitioner states as follows:

1. Petitioner, EMERY, is a political subdivision of the State of Utah that represents the interests of residential and business consumers (citizens) in the State of Utah, many of whom are gas transportation and/or sales customers of Questar Gas Company.

2. Petitioner, EMERY also represents the interests of residents and businesses that currently do not receive services from Questar Gas Company, but have an interest in obtaining natural gas service.

3. The legal rights and interests of Petitioner and its citizens will be substantially affected by this proceeding.

4. Petitioner has not fully determined the specific positions it will take or the relief it will seek. Petitioner seeks to intervene for purposes of protecting its interests and the interests of its citizens as they may appear, particularly on issues of relevance to large consumers.

5. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired if Petitioner is allowed to intervene.
