In accordance with Rule 746-100-7 of the Public Service Commission's ("Commission") Rules of Practice and Procedure and the Provisions of Utah Code Ann. § 63-46b-9, Holcim, Inc., and Kennecott Utah Copper LLC, (these natural gas distribution customers will be referred to hereinafter, for convenience only, as the "Industrial Gas Users" or "IGU"), hereby petition the Utah Public Service Commission ("Commission") for leave to intervene in the above-referenced proceeding, and request that the Commission issue an order allowing IGU to participate fully in this matter.

In support of its Petition to Intervene, the IGU state as follows:

1. On July 1, 2013, Questar Gas Company, ("Questar Gas" or "Company"), filed an application requesting that the Commission approve an increase in its distribution revenue in Utah in the annualized amount of approximately \$18.96 million.

2. The consumers herein referred to as IGU are a group of industrial users of natural gas who each take distribution service from Questar Gas.

3. The consumers herein referred to as IGU have joined together for the purposes of intervention in this docket to have their common interests represented. The interests of each of the IGU consumers will not be adequately represented by any other party to this proceeding.

4. The consumers herein referred to as IGU have a direct, immediate, and substantial interest in this proceeding as customers of Questar Gas because the rate they pay for natural gas distribution service may be affected by a Commission decision on Questar Gas's Application for an increase in its distribution non-gas and/or supplier non-gas rates.

5. If the consumers herein referred to as IGU are granted leave to intervene in this proceeding, they hereby request that service of all pleadings, notices, etc. be made to the following:
