Pursuant to the Report and Order in Docket No. 12-057-13 and the terms and conditions of the Wexpro II Agreement, Questar Gas Company (Questar Gas) respectfully submits this Notice of Intent to File an Application seeking the approval of a certain property under the Wexpro II Agreement.

Wexpro Company (Wexpro) has purchased a property within the Development Drilling Area (as defined in the Wexpro II Agreement). Questar Gas will submit an Application on or about October 18, 2013, seeking the Utah Public Service Commission's (Commission) approval to include that property under the terms and conditions of the Wexpro II Agreement.

Questar Gas notes that Section IV-5 of the Wexpro II Agreement provides for a 60-day timeframe in which to adjudicate the matter. Accordingly, Questar Gas respectfully requests that the Commission set a time for a scheduling conference as soon after October 18, 2013 as practicable.
