On November 12, 2013, the Commission issued a Scheduling Order and Notice of Hearing and Technical Conference (“Scheduling Order”) in this docket. On December 16, 2013, Questar Gas Company (“Questar”) filed a stipulated motion to modify scheduling order (“Motion”).
