Re: **Tariff Compliance Filing in Docket 13-057-T02 with the order in Docket 12-057-14**

## RECOMMENDATION

Approve the tariff sheets filed in docket 13-057-T02, on March 6, 2013.

## ISSUE

On January 9, 2013 the Public Service Commission of Utah (Commission) issued its Report and Order (Order) in Docket No. 12-057-14 approving certain tariff updates to Questar Gas Company's (Company) 2013 Energy Efficiency Programs and Market Transformation Initiative.

The Company filed its initial application in docket 12-057-14 on October 17, 2012. That filing had attached exhibits with its proposed tariff sheets. These tariff sheets would amend its current Utah Natural Gas Tariff PSCU 400, specifically:

§2.09 Thermwise Energy Efficiency;

§2.10 Thermwise Appliance Rebates;

§2.11 Thermwise Builder Rebates;

§2.12 Thermwise Business Rebates;

§2.13 Thermwise Home Energy Audits;

§2.14 Thermwise Weatherization Rebates;

§2.15 Low-Income Weatherization Assistance Program;

§2.16 Thermwise Business Custom Rebates and;

§2.17 Authorized Contractors.

On March 22, 2013, the Commission issued its Action Request to the Division of Public Utilities (Division) to verify the accuracy of the tariff sheets filed on March 6, 2013 for compliance with the Order.

## **DISCUSSION**

The Division has reviewed the updated tariff sheets filed on March 6, 2013 and finds that the attached sheets are in agreement with the those contained in Docket Nos. 12-057-14 as amended and approved by the Commission in its order having an effective date of January 1, 2013. This review also included the revised tariff sheets attached as part of the DSM Group Advisory Consensus Report filed with the Commission on December 21, 2012. The Office of Consumer Services and Salt Lake Community Action Program filed comments expressing concerns with part of the original filing (§2.15 Low-Income Weatherization Assistance Program). The report provided the resolution of these concerns and the amended tariff sheets.

## **CONCLUSION**

The Division recommends the Commission accept the tariff sheets.
