ISSUED: July 1, 2014

On June 24, 2014, Summit Energy, LLC (“Summit”) filed with the Commission in Docket No. 13-057-05 an objection to a unilateral change in procedure and emergency motion for stay (“Objection”). The Objection is directed at Questar Gas Company (“QGC”) and concerns notification sent to certain TS Tariff customers via email on May 12, 2014, regarding nomination procedures on the Questar Pipeline (“QP”) and QGC systems (“Notice”).

UAE Intervention Group and US Magnesium, LLC filed a joinder in the Objection on June 24, 2014. CIMA Energy Ltd filed a joinder to the Objection on June 26, 2014, and Seminole Energy Services, L.L.C. filed a joinder to the Objection on June 30, 2014. On June 26, 2014, QGC filed a memorandum in opposition to motion for stay and on June 27, 2014, QGC filed a corrected memorandum in opposition to motion for stay.

Pursuant to the Commission’s June 24, 2014, notice of scheduling conference, the Commission held a scheduling conference on June 30, 2014. In accordance with the discussion at the conference, the Commission opens this new docket with the following schedule.
