QUESTAR GAS COMPANY'S MOTION
TO AMEND SCHEDULING ORDER

Questar Gas Company (Questar Gas or Company) respectfully submits this Motion to Amend Scheduling Order. On July 1, 2014, the Public Service Commission of Utah (Commission) issued a Scheduling Order and Notices of Technical Conference and Hearing (Scheduling Order). The Scheduling Order required that a Complaint be filed by July 10, 2014, but did not set forth a deadline for Questar Gas to file an Answer to the Complaint. If Questar Gas filed the Answer 30 days after the Complaint, it would be due on August 11, 2014. Questar Gas prefers to answer the Complaint on August 28, 2014, the same day its Direct Testimony is due. Counsel for Questar Gas has communicated with counsel for the Complainants, Counsel for the Division of Public Utilities, Counsel for the Office of Consumer Services and Counsel for Shell Energy North America (US), L.P. All have indicated that the referenced parties do not oppose the proposed answer date. Therefore,

Questar Gas respectfully requests that the Commission amend the Scheduling Order to include a deadline for Questar Gas to file an Answer on August 28, 2014.
