Pursuant to Utah Code §63G-4-207 and Utah Admin. Code R746-100-7, The Kroger Co. (“Petitioner”) hereby petitions the Public Service Commission of Utah (“Commission”) for leave to intervene and participate in the proceeding concerning the application of Questar Gas Company (“Applicant”).

In support of its Petition The Kroger Co. states as follows:

1. On December 18, 2014, Applicant filed an application with the Commission for authority to make tariff modifications to charge customers for use of supplier non-gas services.
2. Petitioner operates numerous grocery stores, a distribution center, a dairy, a bakery and other facilities in the service territory of the Applicant. In total, Kroger has approximately 80 accounts on the Applicants system. The rate increase requested by the Applicant, if approved, would result in significant added cost to the Petitioner.
3. Petitioner has a substantial and diverse interest in the outcome of this case that cannot be adequately represented by any other party.
