On October 9, 2015 Dell and Luceal Ellertson (the Ellertsons) filed a formal complaint against Questar Gas Company (Questar), a public utility. On November 13, 2015, Questar answered the complaint and filed a motion to dismiss it, representing that all issues raised in the complaint have been resolved. The presiding officer now issues the following scheduling order on Questar's motion to dismiss:

1. The Ellertsons may file a response no later than **Monday, November 30, 2015**. The response may be filed in addition to or in lieu of a reply to Questar's answer. If the Ellertsons do not file a response, the matter will be deemed resolved, and the complaint will be dismissed without further notice or proceeding.
2. If the Ellertsons file a timely response, Questar may file a final reply no later than **Tuesday, December 15, 2015**.
