Pursuant to Utah Code Ann. §63G-4-207 and Utah Admin. Code §R746-100-7, Questar Pipeline, LLC ("Questar Pipeline") hereby petitions for leave to intervene in the above-referenced proceeding before the Public Service Commission of Utah ("Commission"). In support of this motion, Questar Pipeline states as follows:

1. On June 14, 2016, Questar Gas Company ("Questar Gas") filed the Integrated Resource Plan for Plan Year June 1, 2016 to May 31, 2017 before the Commission under the above-referenced docket.
2. Questar Pipeline owns and operates an interstate natural gas pipeline and storage system regulated by the Federal Energy Regulatory Commission and provides transportation and storage services to Questar Gas.
3. As a natural gas transportation and storage provider to Questar Gas, Questar Pipeline has a direct interest in this proceeding and the outcome may have a substantial effect on Questar Pipeline's legal rights and interests.

4. Questar Pipeline's interest in the outcome of this proceeding will not be adequately represented by any other party, and if Questar Pipeline is allowed to intervene, such intervention will not unduly delay the proceeding, nor prejudice the rights of the original parties.

5. Questar Pipeline has not yet determined what, if any, relief it may seek to protect its interests.
