FROM ELECTRONIC FILING
REQUIREMENT

ISSUED: June 8, 2017

On June 2, 2017, Dominion Energy of Utah ("DEU") filed a motion to deviate from Utah Admin. Code R746-1-203, which sets forth an electronic filing requirement. In filing this motion, DEU represents that its Third Quarter Variance Report ("Variance Report") contains confidential information and DEU does not yet have access to the Public Service Commission of Utah's ("PSC") SFTP system. DEU states it is currently working with its IT department and the PSC to implement the new SFTP protocol so that confidential information can be filed electronically. In this instance DEU must deviate from the rule in order to file the Variance Report in a timely manner. DEU attests that the rule imposes a hardship that outweighs its benefits. Utah Admin. Code R746-1-109(2).

Given the foregoing, the PSC grants the motion to deviate and permits DEU to submit a disc in order to provide confidential information relative to the Third Quarter Variance Report.
