On September 29, 2016, Questar Gas Company (Questar) filed an application in this docket (Application). Questar's Application includes a proposed amortization rate for the Account No. 182.4 balance. The Public Service Commission (Commission) observes that the proposed amortization rate of \$0.19385 given on page three of the Application does not appear to be the result of dividing the projected amortization amount of \$23,721,856 by the test period volumes of 101,981,358 shown on page four. Rather, the result of this computation appears to yield a rate of \$0.23261. The Commission further observes that substituting the \$0.23261 rate in Exhibit 1.3, Forecast Amortization tab, cell C9 and recalculating the projected ending monthly balances appears to provide a significantly different result over the projected period.

The Commission requests that Questar come to the previously-noticed October 6, 2016 scheduling conference prepared to clarify this apparent discrepancy.
