Questar Gas Company (Questar Gas or the Company) respectfully submits the attached Exhibit 1.5U as an update and correction to the Application in this matter.

On September 29, 2016, the Company filed an Application in this docket requesting that the Utah Public Service Commission (Commission) enter an order authorizing Questar Gas to change the Energy Efficiency (EE) amortization rates and charges applicable to its Utah natural gas service territory.

The Company has since discovered that Exhibit 1.5 to the Application erroneously included the proposed changes to the Conservation Enabling Tariff amortization. The attached Exhibit 1.5U has been corrected to remove the erroneously-included rate information.

The error in exhibit 1.5 is also reflected in the second paragraph and the last sentence of section three of the application. These sentences indicate that customers “will see a decrease in their yearly bills of \$9.56 (or 1.41%).” The decrease is actually \$3.96 (or .58%). This will be corrected by the Company’s witness at the hearing for this Docket on October 31st.

Based upon the foregoing, Questar Gas respectfully submits Supplemental and Updated Exhibit 1.5U and requests that the Commission include said exhibit in this docket.
