SCHEDULING ORDER AND  
NOTICE OF HEARING

ISSUED: October 25, 2016

On October 20, 2016, the Division of Public Utilities (Division) filed with the Public Service Commission of Utah (Commission) a request for agency action (Request). The Request alleges that Michael Moyal (Mr. Moyal) is operating a Master Meter System that fails to comply with numerous federal and state safety requirements. The Division requests discovery in this matter, a Hazardous Facility Order,<sup>1</sup> a Compliance Order, and potential sanctions including a civil penalty of up to \$1,000,000.

Pursuant to Utah Admin. Code R746-100-1, this matter shall be adjudicated as a formal administrative proceeding.

SCHEDULING ORDER

1. Mr. Moyal shall file a response to the Division's Request no later than **Wednesday, November 23, 2016**. Failure to file a response will result in a default order against Mr. Moyal pursuant to Utah Code § 63G-4-209(1)(c).
2. If Mr. Moyal files a timely response, the Division may file a final reply no later than **Thursday, December 8, 2016**.
3. The parties shall complete discovery by **Thursday, December 22, 2016**.

<sup>1</sup> The Division has not requested that the Hazardous Facility Order be issued without hearing due to likelihood of serious harm to life or property. Utah Admin. Code R746-409-6(C). If the Division considers that immediate action is required, the Commission will accept a supplemental filing.

4. Any dispositive motion shall be filed no later than **Thursday, December 29, 2016**. If any such motion is filed, the presiding officer will issue a supplemental scheduling order setting deadlines for response and reply and scheduling oral argument, if required or requested.
5. No later than **Thursday, January 12, 2017**, the parties shall exchange disclosures regarding evidence that will be introduced at hearing.

HEARING NOTICE

The hearing in this matter shall be held on **Wednesday, January 18, 2017**, beginning at 9:00 A.M. in Fourth Floor Hearing Room 403 of the Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.

Individuals wishing to participate in the hearing by telephone should contact the Public Service Commission two days in advance at (801) 530-6716 or (toll free) 1-866-PSC-UTAH (1-866-722-8824) to receive a bridge number and participant passcode. Participants attending by telephone should then call the bridge number five minutes before the hearing, entering the passcode followed by the # sign to ensure participation.
