Pursuant to the Order Approving Stipulation in Docket No. 15-057-10, Questar Gas is filing its report of the five-year forward curve. This is the same curve that was presented at the August 2, 2017 IRP technical conference. The curve is included as Attachment 1. This curve was calculated using the same method as described in paragraph 14 of the Settlement Stipulation in Docket No. 15-057-10. The spreadsheet detailing the calculations in the five-year forward curve is included as attachment 2. For informational purposes, we have also included Attachment 3, which shows that during the 2015-2016 IRP year, 60% of the forecast demand for Questar Gas customers was supplied by Wexpro production.





2016 – 2017 IRP Year Production






Calculation of 5-Year Forward Curve
