US MAGNESIUM, LLC'S REQUEST FOR ISSUANCE OF SUBPOENA

Pursuant to Utah Administrative Rule R746-1-501(5)(a), US Magnesium, LLC ("US Mag") hereby submits this Request for Issuance of Subpoena. The basis for US Mag's Request is set forth below:


On March 12, 2018, the Public Service Commission of Utah ("Commission") issued its Order Granting Partial Summary Judgment ("Order") in this docket. As part of the Order, the Commission stated as follows: "We order both parties to provide the PSC at the time of the hearing with copies of their respective detailed phone records showing all calls and text messages made and received on January 6, 2017, the times of each call and text message, and the duration of each call." Order at 14. US Mag recently learned that it cannot obtain some of the records it has been ordered to produce without issuing a subpoena for those records.

Specifically, US Mag has learned that in order to obtain the relevant mobile phone records of its witness, Roger Swenson, it must issue a subpoena to the AT&T Global Legal Demand Center.

R746-1-501(5) states that “[a] party that requires a subpoena for discovery purposes shall: (a) present the subpoena to the Commission for signature; and (b) serve the subpoena pursuant to Utah Rule of Civil Procedure 45(b)(1). With this Request, US Mag hereby presents the subpoena to the Commission for signature. Once signed, US Mag will serve the subpoena on AT&T. The subpoena for relevant records is submitted herewith and US Mag hereby requests that the Commission sign the subpoena.
