October 2016 statement showed I owed \$12.57. I paid because it showed a \$262.44 credit and gas company in previous years catch you up when on a budget plan until a re-evaluation is done.

Sometime in February 2017 received statement of gas bill being \$22.00 since I had a credit in October 2016 I knew I should not be getting another credit so I called. Talked to an employee and told her something was not right my gas bill is usually \$125.00 budget plan. She told me I had a credit of \$345.55. Said this can't be right, what will my bill be for March she said \$22.00. Said my house is 4600 sq feet with cathedral ceilings. I asked how long will I be billed \$22.00 she said until August 2017 when they will re-evaluate your gas usage. Again I asked her if there will be a change in the billing and she said NO!

Sometime in May 2017 a questar female rang my door and said she needed to change the radio transponder she called it a pinger, said when she drives by aims it and gets a reading from my meter. I asked her if that would cause a problem with my gas statement because I had a credit and my bill was just \$22.00 till August when they will re-evaluate it. She said it will not create a problem. Changed the radio transponder then left.

Then June statement for \$170.00 called 6-13-17 to alert them that I was told my bill would be \$22.00 til August and a re-evaluation.

6-15-17 called to dispute bill because I was told gas company equipment failed. I don't own it, I can't replace it, I can't touch it. So it is NOT MY PROBLEM. Statement for \$170.00 and now no credit but instead I owe them Debit \$614.12.

People I have talked to @ gas company:

6-13-17 Kay **lee-** I told her lets let a Judge decide what I should pay and if I have to be backed billed. She said sorry wouldn't get to see a judge the gas company will send you to collections.

6-15-17 Called Kay Lee back asked to speak to her boss about the over charge. She gave me to Bailey, who gave me to Cindy 801-324-3810 who said to talk to Karen.

6-28-17 Called Karen told me to talk to Cynthia 801-530-6675 (Consumer affairs).

7-3-17 called Cynthia who said I would have a assigned analyst with questar gas respond to be by July 6,2017. Elia Lopez 801-324-3557 will be my analyst.

7-5-17 Elia called said got my \$22.00 dollar check needed to pay the \$170.00 again I told her I was told my bill would be \$22.00 tile August 2017. She said I needed to pay my usage PLUS \$49.35 a month till my debit to the company is paid and a reevaluation would happen in September. Then will talk in September of what I will be charged next if I want budget plan.

7-6-17 Elia to send me a copy of letter I never received from Sabrina (billing analyst) dated 6-2-17. And a copy of the gas tariff law.

After talking to Elia I received her letter (dated 7-7-17) in the mail.

This is what some of the letter states and copy included: "Dominion Energy uses gas meters with indexes to record our customer' consumption. Our gas meters are read through a transponder; a small radio receiver/transmitter that sends reads to a radio-equipped vehicle. Both gas meter index and the transponder record consumption—it is a double—check system.

All accounts have billing parameters based on consumption history. Your March usage was low and did not meet the parameters set for your account. An inspection of your gas meter and transponder was scheduled. On May 25, 2017, out technician visited your home. The gas meter was reported to be working accurately and an index read of 8093 was reported. Your transponder had stopped working; therefore, you had not been billed for the gas you actually used. A 6-

month adjustment was completed to bill you for the gas that went through the gas meter as recorded by the gas meter index. A copy of the letter dated June 2, 2017 and the itemization showing you the adjustment is enclosed for your review."

Again gas equipment failed not my fault. The worker said she just needed to replace the transponder.

8-23-17 Questar/Dominion field employee showed up to my door wanting to change out my gas meter. WTS! I said not today. And please have your boss call me. Gave him my business cart and told him I had an ongoing problem with the gas company.

8-24-17 John (801-324-1106) called me and I told him of an on going dispute and he understood. Just told me it was just lucky I got picked to get a new meter. Asked who else on my street gets a new meter too? He said it's random and you were the one chosen?

Random? Sounds fishy to me.

Last summer the water company billed me high I called them and said why they told me I must have a pluming problem or a sprinkler problem to get such a high bill.

Plumper said nothing wrong.

Sprinkler man said nothing wrong.

You see if you are using a lot of water they will say nothing but if your water usage is lower than previous years then they will say something. At that time I asked them to change my meter the

Manager who I got to talk to must be as ugly as she sounded. It must have been late in the afternoon when I called but at 8AM the next morning a 2 man crew showed up to changed out my water meter. Of course they said nothing was wrong with the meter. HA. . Then why did my bill go lower and my usage when my watering habits had not changed? And it has been low and back to normal since. At that time, the public commission told me they could not help me with the Salt Lake Water District? Who knows if that's correct?

This is what I think is going on with the gas company. They compare usage with precious years. I have called several times within the few years to cut down on my gas usage because I am on a fixed income now. I want to conserve and they have given me facts to accomplish this. It has been working because my gas consumption has been lower. January 2016 my budget amount was \$160.00, in April 2016 my budget amount went down to \$125.00.

If I have a piece of equipment that is not functioning correctly I the owner of the equipment need to get it fixed. AS well if questar/dominion equipment they **OWN** is not working they need to get it fixed.

Last week I bought a pie at Sam's club that is 8.98 but the sticker on the pie says 5.98 that is what I paid. I talked to a manager and showed him the pie was marked wrong and to talk to bakery. He said you got a good deal on those 3 pies today. And I

said Yes I did. He did not back bill me the difference of \$3.00 per pie.

Companies are no different than individuals. They need to be responsible and accountable for their equipment and accuracy of their billing statements.

AS stated by Questar/Dominion my bill should be \$22.00 till August and at that time a re-evaluation would be done.

Your Dominion Energy account was on budget billing. Your February 6, 2017 billing statement (copy enclosed) showed your budget plan was re-evaluated which dropped your monthly installment from \$125.00 to \$22.00. Your statement also showed a budget plan balance of (credit) \$345.55. You called our Customer Care Department on February 10, 2017 and our representative confirmed the re-evaluation. Based on our telephone conversation, budget billing has been dropped and your account set up on a 12-month interest-free Deferred Payment Agreement (DPA). I will call you in August to discuss the budget re-evaluation, and, if you are interested, to restore budget billing. BILLING ADJUSTMENTS

LOCAL CHARGES

These local charges cannot exceed 6%, either separately or combined. Monthly bills for customers within the corporate limits of a municipality imposing any local charges will show a separately itemized line for each applicable local charge. The franchise fee is calculated by applying the franchise fee percentage to the total customer charges for gas service. The MET is calculated by applying the MET percentage to the total customer charges for gas service, including any franchise fee. In municipalities with both a franchise fee and an MET, the franchise fee percentage is allowed as a credit against the MET percentage. To reflect the credit of the franchise fee against the MET, the customer's bill will show a "net MET"


