The undersigned, representing Dominion Energy Utah (Dominion Energy or Company) hereby moves the Public Service Commission of Utah (Commission) for permission to deviate from the electronic filing requirement set forth in Utah Admin. Code R746-1-203. Pursuant to Admin Code R746-1-109(2), movant attests that the rule imposes a hardship that outweighs the benefit(s) of the rule.

Dominion Energy is prepared to file its Answer to Formal Complaint of Check Line, Inc. and James Evans (Answer) in the above-referenced docket with the Commission. However, the Answer contains Confidential Information and Dominion Energy does not yet have access to the Commission's SFTP system. Dominion Energy is currently working with its IT department and the Commission Staff to implement the new SFTP protocol so that confidential information can be filed electronically. The Company realizes the importance of filing the Answer in a timely

manner but, to do so, it must deviate from the rule in this instance. Therefore, the Company moves the Commission for leave to deviate from the rule in filing the Answer.
