On September 19, 2017, Complainants, Check Line, Inc. and James Evans, (Complainants or Mr. Evans) filed a Formal Complaint against Questar Gas Company dba Dominion Energy Utah (Dominion Energy Utah or Company) seeking an Order by the Utah Public Service Commission (Commission) to prohibit the Company from charging Mr. Evans for service at 3762 W. 5400 S, Salt Lake City, Utah 84129 after June of 2016.

On October 10, 2017, Dominion Energy Utah filed its Response to the Complaint, and attached an account itemization as Exhibit A to the Response.

The Commission scheduled this matter for hearing on December 12, 2017.


During the hearing, Mr. Evans expressed concern that his account information had become public. In an effort to address Mr. Evan's concerns, the Company agreed to maintain information in this docket as confidential and moved that the Commission immediately remove of Exhibit A to the Company's Response, and to resubmit Exhibit A as Confidential subject to Utah Admin. Code §§ R746-1-602 and 603. Motion was granted and Company's Exhibit A was immediately removed from the

Commission Website. The hearing officer further ordered the Company to submit its anticipated hearing exhibits as Confidential.

Accordingly, the Company respectfully submits Attachment 1, containing the required Confidential exhibits, and Attachment 2, containing the same documents in non-confidential, redacted form.


