**STIPULATED MOTION FOR ENTRY
OF SCHEDULING ORDER**

Pursuant to Utah Code Ann. § 54-4-1 *et seq.* and Utah Rule of Administrative Procedure R746-1-301, Questar Gas Company dba Dominion Energy Utah (“Dominion” or “the Company”), the Utah Division of Public Utilities (“Division”), and the Office of Consumer Services (“Office”) stipulate and move the Commission to approve the following schedule in this docket to address the peak-hour service contracts (the “Contracts”). Specifically, due to questions raised regarding the purpose and necessity of the Contracts, Dominion, the Division, the Office and the Utah Association of Energy Users (UAE) have conferred to discuss a procedure whereby those concerns might be addressed and resolved in this docket. The Parties

have agreed that the rates and charges related to the Contracts may go into effect on an interim basis pending the conclusion of this matter. Additionally, the parties recognize that the Division is in the process of completing their audit of the 191 Account for this test period and may find other areas that need additional review. Based on these discussions, Dominion, the Division, the Office and the UAE have stipulated to the following procedure and dates for addressing questions related to the Contract, and move the Commission to approve them:

Direct Testimony of Dominion	November 30, 2017
Direct Testimony of Other Parties	January 31, 2018
Deadline to Intervene	February 7, 2018
Rebuttal Testimony	February 21, 2018
Surebuttal Testimony	March 12, 2018
Hearing on Contract	March 14 or 15, 2018

The parties propose that they would have 14 days to respond to data requests served prior to January 31, 2018, and seven days to respond to any data requests served after that date, with the parties using their best efforts to respond as expeditiously as practicable.
