On November 27, 2017, the Division of Public Utilities (DPU) filed a request for expedited scheduling conference in Docket Nos. 17-057-20 and 17-057-21. After the PSC's Presiding Officer communicated with the parties informally via electronic-mail seeking clarification of the requested scheduling conference and respective positions of the parties about the DPU's request, a Notice of Scheduling Conference was scheduled for November 29, 2017.

At the November 29, 2017 scheduling conference, the DPU clarified, and the parties agreed, that the request for expedited scheduling conference should pertain to only Docket No. 17-057-20. Accordingly, based on the discussion at the scheduling conference, the parties agreed to the following amended schedule, which the PSC adopts:

DISCOVERY AND FILINGS

Parties shall respond to requests for data or discovery no later than fourteen (14) days to requests served before April 13, 2018, and seven (7) days or best efforts thereafter. Parties shall serve copies of all filings on other parties by electronic mail at or before the time an electronic copy of the document is filed with the PSC. In the event a document filed with the PSC or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) with the PSC by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.

NOTICE OF HEARING

The PSC's designated Presiding Officer will conduct a hearing in this docket on **Wednesday, May 30, 2018, beginning at 9:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** All parties must have their witnesses in attendance and prepared to testify.
