In its November 29, 2017 Scheduling Order, the Public Service Commission (“PSC”) scheduled this matter for hearing on May 30, 2018. Subsequently, the PSC scheduled a multi-day hearing in another docket (Docket No. 17-035-40), involving a different utility, from May 29-31, 2018. This latter docket involves significant time sensitivities and parties’ scheduling conflicts necessitated scheduling the hearing on those dates. The PSC is able and willing to conduct both hearings as scheduled. However, the PSC is mindful that some parties to both dockets may have limitations on resources, such as personnel and legal counsel, which make the schedule difficult. The PSC acknowledges the hearing date in this docket has been set for several months, but we ask parties to provide comments on or before **Friday, February 23, 2018**, indicating whether the party objects to rescheduling the hearing in this docket for a date in June 2018 and also indicating any dates during that month on which the party cannot participate in a hearing in this docket.
