**UAE'S COMMENTS IN RESPONSE TO FEBRUARY 15, 2018 NOTICE AND
REQUEST FOR COMMENTS**

In its February 15, 2018 Notice and Request for Comments in this docket, the Commission notified parties that the currently scheduled hearing in this matter would overlap with a multi-day hearing scheduled in another matter before the Commission and requested that the parties provide comments indicating whether any party objects to rescheduling the hearing in this docket for a date in June 2018. UAE responds as follows:

UAE would prefer that the hearing in this docket and the hearing in Docket No. 17-035-40 not occur at the same time. While UAE could manage both hearings as currently scheduled if necessary, UAE does not object to rescheduling the hearing in this docket so long as an acceptable alternative date in or after June 2018 can be found during which UAE does not have a scheduling conflict. Currently, UAE could accommodate a hearing date in this docket between

June 1-13, 2018. UAE has significant scheduling conflicts in the second half of June 2018 and would object to rescheduling this hearing to a date between June 14-30, 2018.
