Pursuant to rule R746-1-301 of the Public Service Commission of Utah's rules (Commission), the Utah Division of Public Utilities (Division) hereby files this Unopposed Motion for Extension of Time to File Direct Testimony and Request for Expedited Treatment in this docket (Motion).

The Division requests that its consultant, Mr. Howard Lubow, be allowed to file his Direct Testimony on April 23, 2018 rather than on the scheduled date of April 20, 2018. Despite efforts by Dominion Energy of Utah (Dominion) and Mr. Lubow, it took additional time for certain of Dominion's data responses to be prepared and presented to the Division. Mr. Lubow requests the additional time to allow him to analyze these
