ISSUED: April 17, 2018

On March 2, 2018, the Public Service Commission (“PSC”) issued a Second Amended Scheduling Order and Notice of Hearing, establishing April 20, 2018 as the deadline for all parties other than Dominion Energy Utah (“Dominion”) to file direct testimony. On April 16, 2018, the Division of Public Utilities (“DPU”) filed an Unopposed Motion for Extension of Time to File Direct Testimony and Request for Expedited Treatment (“Motion”). The DPU is requesting that its consultant, Mr. Howard Lubow, be allowed to file his direct testimony on April 23, 2018, rather than on the April 20, 2018 deadline. The DPU states it is authorized to represent that Dominion, the Office of Consumer Services, and the Utah Association of Energy Users do not oppose the DPU’s Motion.

Therefore, good cause appearing and there being no objection, the Motion is granted.
