THIRD AMENDED SCHEDULING ORDER

ISSUED: April 19, 2018

On April 16, 2018, the Division of Public Utilities (“DPU”) filed an Unopposed Motion for Extension of Time to File Direct Testimony and Request for Expedited Treatment (“Motion”). On April 17, 2018, the Public Service Commission (“PSC”) granted the Motion, extending the deadline to April 23, 2018 for the DPU’s witness to file direct testimony. On April 18, 2018, the DPU, the Office of Consumer Services, the Utah Association of Energy Users, and Dominion Energy Utah (collectively known as the “Joint Parties”) filed a Joint Motion for Extension of Time to File Direct Testimony and Request for Expedited Treatment (“Joint Parties’ Motion”). In the Joint Parties’ Motion, the Joint Parties request that the PSC extend the filing date for the Joint Parties to file testimony on April 23, 2018.
