DOMINION ENERGY UTAH'S ANSWER

Questar Gas Company dba Dominion Energy Utah (Dominion Energy or Company) respectfully submits this response to the Formal Complaint of S. Koyle (Mr. Koyle) in the above-referenced docket.

The Company processes check payments via electronic funds transfer. The Company has notified customers of this practice on the reverse side of each bill which indicates that "Paying by check authorizes us to use the information from your check to make a one-time electronic funds transfer from your account. The funds may be withdrawn as early as the date we receive your payment, and you will not receive your check back from your financial institution." *See* DEU Exhibit A. The Company provides other options for payment including automatic bank draft, credit card, debit card, cashier check and online payments.

On August 1, 2017, Mr. Koyle submitted a check for payment of his natural gas bill. That bill contained the statement set forth above. *Id.* Upon information and belief, sometime thereafter, Mr. Koyle noticed the check was processed as an electronic funds transfer. Mr. Koyle indicated that he does not authorize electronic fund transfers and "requires" that an image of his cashed check to be returned to him.

The Company currently has a process that would allow the transmission of the check image to the Company's financial institution. The Company cannot require a bank (its financial institution or Mr. Koyle's) to provide customers with copies of digital images of checks that have been endorsed. The Company does not know if Mr. Koyle's financial institution allows such process.

On August 15, 2017, Mr. Koyle contacted Company and Company representatives identified other available methods of payment. Nonetheless, Mr. Koyle declined.

On August 23, 2017, Mr. Koyle submitted a check payment for his natural gas bill containing a notation that "check void if electronically cashed."

The Company offers a number of means of payment and cannot control financial institutions' policies regarding return of endorsed checks. The Company has complied with all applicable statutes, rules, regulations and Tariff provisions and the Utah Public Service Commission should deny Mr. Koyle's complaint.



Adjustments These are refunds cradditional charges related to your scoount.

Basic Service Feet A charge to cover the cost associated with mater reading and billing, return on investment, property tax and depreciation for meters, regulators, and service lines.

Budget Pien Amount: An estimate based on a customer's annual gas usage, divided into 12 monthly payments.

Budget Fian Eulance: A "credit" balance occurs when the cumulative billings, based on actual gas usage, are lower than the total budget amounts paid. A "debit" balance occurs when the cumulative billings, based on actual gas usage, are higher than the total budget amounts psid. Upon cancellation of service, the full debit balance will be due.

CCF: A unit of measurement equal to 100 cubic feet.

Chesicable Contribuctions: Avolution of their gas bills disabled and alderly outcomers with low income pay a partien of their gas bill. These funds are distributed through Uten's REACH program and Energy Share of Wyoming—100 percent of all donations help those in need. (To sign up, sontact Dominion Energy)

Dekatheres (Dth): A standard measurement for heat, which is equal to 1 million Btu (British Thermal Units).

BPA Weisered Payment Agreement): A payment amongement where a past-due balance can be divided into smaller amounts and paid over a specified particular films.

Electronic Check Conversion: Paying by checkauthorizes us to use the information from your check to make a one-time electronic funde transfer from your account. The funda may be withdrawn as early as the date we receive your payment, and you will not receive your check backfrom yourfinancial institution.

Energy Assistance Fund: A tes Dominion Energy is required to collect from all Utah customers to help easist people with low income pay a portion of their gas bill. Utah HEAT offices administer these funds.

MGR A unit of measurament equal to 1,000 cubic feet.

Place Cody: This indicates the rate achecule used for billing. The current rate schedules are available at Dominion Energy, com.

Welume Mukipien Trie is a factor used to convert gas volume into dekatherms, included in the factor are a number of values including Btu, regulator pressure, elevation, etc.
