On May 16, 2018, Questar Gas Company dba Dominion Energy Utah, the Division of Public Utilities, the Office of Consumer Services and the Utah Association of Energy Users jointly filed a Settlement Stipulation in this docket. The Public Service Commission (“PSC”) gives notice its designated Presiding Officer will conduct a hearing to receive testimony with respect to the Settlement Stipulation on **Thursday, May 24, 2018, beginning at 9:00 a.m.** The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** The parties should come to hearing with a representative prepared to offer testimony as to whether the Settlement Stipulation is just and reasonable in result as contemplated under Utah Code Ann. § 54-7-1.
