The OCS further suggests DEU present its plans for a Tax Reform Surcredit 2 ending balance true-up. In reply comments filed on July 25, 2018, Dominion Energy Utah ("DEU") proposes to address the ending Tax Reform Surcredit 2 balance amount by clearing out the remaining over- or under-recovery in the Tax Reform Surcredit 2 account to \$0 through corresponding entries made to the integrity management expense rider. DEU adds that the balance in the integrity management account is allocated to all classes and will be updated in the forthcoming 2019 general rate case.
