APPLICATION

Pursuant to Utah Admin. Code R746-405-1 (2016), *et seq.*, and Paragraph 17 of the Settlement Stipulation filed in Docket No. 16-057-01 (the Merger Docket) and approved by the Utah Public Service Commission (Commission) as memorialized in its Order Memorializing Bench Ruling Approving Settlement Stipulation dated September 14, 2016 in the same docket (Merger Order), Questar Gas Company dba Dominion Energy Utah (Dominion Energy Utah or Company) respectfully requests that the Commission issue an order approving the Company's new Natural Gas Tariff No. 500 (Tariff) bearing the Company's new name, "Dominion Energy Utah."

On January 31, 2016, Dominion Resources, Inc. (Dominion) and Questar Corporation, the Company's parent company, agreed to merge. On March 3, 2016, Dominion and Questar Gas Company filed a Joint Notice and Application for approval of the merger in the Merger Docket. On August 15, 2017, the parties to the Merger Docket filed a Settlement Stipulation. Among other things, the Settlement Stipulation provided that

Dominion Questar Gas will not seek any changes to existing filed rates, rules, regulations, and classifications under Questar Gas' Utah Natural Gas Tariff No. 400 ("Tariff") because of the Merger, before its next general rate case, except to revise the Tariff to change the name of the operating entity. The Company will file for a name change within 21 days of the Effective Time.

Settlement Stipulation, Page 7, Paragraph 17. On August 22, 2016, the Commission held a hearing on the matter and approved the merger and the Settlement Stipulation in a bench ruling. On September 14, 2016, the Commission issued the Merger Order memorializing the prior bench order. On October 7, 2017, the Company notified the Commission by letter that it did not intend to change its name at that time.

On May 10, 2017, the Company's shareholders voted to change Dominion Resources, Inc.'s name to Dominion Energy and for most subsidiaries, including Questar Gas Company, to begin operating using similar branding. Accordingly, Questar Gas Company is now Questar Gas Company dba Dominion Energy Utah in the state of Utah. The Company seeks to modify its Tariff to reflect its new name, "Dominion Energy Utah." The Company has attached for the Commission's review and approval an updated Tariff in legislative and final format, reflecting the Company's new name. There are no other changes to the Tariff.

The proposed Tariff sheets do not constitute a violation of state law or Commission rule and are consistent with applicable statutes, rules and orders and this

Application is otherwise compliant with Utah Admin. Code R746-405-2 (2016).

Based upon the foregoing, the Company respectfully requests that the Commission approve the attached Utah Natural Gas Tariff No. 500, effective June 1, 2017.
