**JOINT MOTION TO EXTEND  
BRIEFING SCHEDULE**

Questar Gas Company dba Dominion Energy Utah (“Dominion Energy” or “Company”), Rocky Mountain Gas Association (“RMGA”), the Utah Home Builders Association (“UHBA”), the Utah Plumbing & Heating Contractors Association (“UBHCA”), and the Independent Electrical Contractors Association of Utah (“IECAU”) (collectively, “Movants”) hereby move the Commission to enter an order extending the briefing schedule on RMGA Motion to Reconsider, filed on August 29, 2017, and UHBA’s Motion to Reconsider, filed on August 29, 2017, to allow Movants sufficient time to meet and discuss the matters raised in those motions to (i) determine whether those matters can be addressed through informal discussions, or, (ii) alternatively, all Movants to better understand each other’s respective positions and, if possible,


narrow the issues for the Commission to address, if further proceedings are deemed necessary. To facilitate this meeting, Movants ask the Commission to extend the due date for Dominion Energy's response to the Motions to Reconsider to September 22, 2017. RMGA and UHBA's deadline to reply to any response from Dominion Energy would be 10 days following that deadline, as provided in Rule R746-1-301 of the Public Service Commission Administrative Procedures Act.

The basis for this Joint Motion is that Dominion Energy and the other Movants are attempting to find a date and time to meet and discuss the matters raised in the pending motions. Due to scheduling conflicts, Movants cannot meet until the week of September 18, 2017. Movants believe that holding this meeting prior to any response to the Motions to Reconsider may eliminate the necessity of further briefing or, alternatively allow Movants to better understand each other's respective positions and focus the briefing on the matters the Commission will need to address. Given the Movants' scheduling constraints, extending Dominion Energy's response deadline to the Motions to Reconsider to September 22, 2017 will allow Movants to meet prior to that date. Movants understand that all response or briefing deadlines relating to RMGA, UHBA, UBHCA, and IECAU's Petition for Declaratory Ruling will be established during the Scheduling Conference currently set for September 21, 2017. For that reason, it is unnecessary to modify any briefing or response deadlines for the Petition at this time.

Counsel for Dominion Energy has received authorization from each of the other Movants to represent that they agree with this Joint Motion and, specifically, the proposed extended deadlines discussed above.

Based on the foregoing, Movants request that the Commission issue an order extending the briefing schedule on the Motions to Reconsider as requested above.
