On September 12, 2017, Dominion Energy Utah ("Dominion Energy") filed a Joint Motion to Extend Briefing Schedule, requesting an extension to file responses to the two pending Motions for Reconsideration in this docket. Dominion Energy asks the responses be due by September 22, 2017. Dominion Energy represents it requires the extensions to facilitate discussion between the parties that may potentially resolve one or more disputed issues. Dominion Energy further represents it has authorization from each of the moving parties to represent they consent to the extension.

Good cause appearing, Dominion Energy may file responses to the Motions for Reconsideration on or before September 22, 2017. To facilitate this extension, the Public Service Commission orders the Motions for Reconsideration will be considered after they are fully briefed and, therefore, will not be denied by operation of statute after 20 days as would otherwise be the case pursuant to Utah Code Ann. § 63G-4-302.
