WITHDRAWAL OF MOTION TO
RECONSIDER AND FROM PETITION
FOR DECLARATORY RULING

The Utah Homebuilders Association (UHBA) respectfully submits this Withdrawal of Motion to Reconsider and from Petition for Declaratory Ruling based upon the cause set forth below.

On August 28, 2017, the UHBA filed a Motion to Reconsider requesting that the Utah Public Service Commission (Commission) stop certain activities related to the implementation of the tariff provision approved in this docket and rescind approval of that tariff language.

On September 1, 2017, the UHBA joined the Rocky Mountain Gas Association, the Utah Plumbing & Heating Contractors Association, and the Independent Electrical Contractors Association of Utah in petitioning the Commission for a declaratory ruling to rescind the tariff provisions previously approved in this docket, reconsider the tariff provisions, and stay implementation of activities related to that tariff language pending the Commission's order on their petition.

Since that time, representatives of the UHBA met with representatives of Dominion Energy Utah to discuss concerns with the tariff language approved in this

docket. The UHBA is satisfied that Dominion Energy Utah has sufficiently addressed its concerns.

Therefore, the UHBA respectfully withdraws the Motion to Reconsider it filed on August 28, 2017, and withdraws from the Petition for Declaratory Ruling filed on September 1, 2017.
