VOLUNTARY REQUEST FOR  
APPROVAL OF RESOURCE DECISION

Pursuant to Utah Administrative Code R746-440-1(2)(a) and (2)(b), Questar Gas Company dba Dominion Energy Utah (“Dominion Energy” or “Company”), hereby provides public notice that it intends to file a voluntary request for approval of a resource decision (“Request”) seeking approval of the decision to construct a liquefied natural gas (“LNG”) facility on a proposed site near Magna, Utah, consisting of a 15 million gallon LNG storage tank, an amine gas-pretreatment process, a liquefaction cold box, and gas vaporization facilities. As proposed, the facility would have liquefaction rate of 8.2MMcfd and a proposed vaporization rate of 150 MMcfd (approximately 150,000 Dth/day). Dominion Energy will file the Request as

soon as it has finalized the application and supporting testimony.
