NOTICE REGARDING MOTION TO  
MODIFY SCHEDULING ORDER

ISSUED: September 24, 2018

On September 21, 2018, Dominion Energy Utah (“DEU”) filed a Motion to Modify Scheduling Order. DEU requests the Public Service Commission of Utah (“PSC”) allow DEU to present additional live testimony, in addition to the written testimony that has been filed in this docket, at the hearing scheduled to begin on October 1, 2018. DEU asserts this is necessary to address matters raised in written surrebuttal testimony.

The PSC can consider this motion if DEU supplements the motion with:

- (1) the specific facts or arguments raised in written surrebuttal that DEU alleges it must respond to with additional live testimony;
- (2) the extent to which those facts or arguments are responsive to DEU’s rebuttal testimony; and
- (3) the impact of those facts and testimony on the adequacy of DEU’s original application.

Any other party is free to file comments with the PSC on any of these issues. However, until DEU files the requested supplementary material, the PSC is not setting any deadline or schedule to address this motion, although it is possible the motion will have to be addressed to some extent at the outset of the hearing on October 1, 2018.
