On July 2, 2018, Dominion Energy Utah ("Dominion") submitted its Affiliate Transaction Report for the 12 months ending December 31, 2017 ("Report"), pursuant to the Order Memorializing Bench Ruling Approving Settlement Stipulation in Docket No. 16-057-01, and paragraph 45 of the Settlement Stipulation attached thereto. The Public Service Commission ("PSC") issued a notice of filing and comment period on July 3, 2018, setting comments for August 1, 2018, and reply comments for August 15, 2018.
