
Pursuant to Utah Code Ann. § 54-4-1 *et seq.* and Utah Rule of Administrative Procedure R746-1-301, Questar Gas Company dba Dominion Energy Utah (“Dominion” or “the Company”) moves the Commission to amend the Scheduling Order in this matter to extend the due date for reply comments by one week from July 12, 2018 to July 19, 2018. The Company requests this change to provide it with additional time to work with Dominion Products & Services (“DPS”) and HomeServe to attempt to address concerns raised by the Office of Consumer Services (“Office”) in its June 28, 2018 Memorandum and by the Division of Public Utilities (“Division”) in its Recommendation also dated June 28, 2018.

Since receiving the Memorandum and the Recommendation, the Company has worked diligently to coordinate with DPS and HomeServe to work to address issues raised by the Division and the Office. However, travel schedules associated with the July 4th holiday and the fact that necessary participants in the effort are located in multiple locations has made the coordination of schedules difficult. As a result, the Company is in need of additional time to complete work necessary for its reply comments.

Counsel for the Company has communicated with counsel for the Division and the Office and can represent that neither the Division nor the Office opposes the requested change in the deadline for reply comments in the Scheduling Order. Further, the Company also notes that granting this requested change will not have any other impact on the schedule as there are no other set dates in this matter.
