Pursuant to the Report and Order issued on October 4, 2018 in Docket No. 18-057-07 (Order), Questar Gas Company dba Dominion Energy Utah (DEU or Company) respectfully submits the attached Clarification Letters. In the Order, the Utah Public Service Commission (Commission) ordered, in relevant part, as follows:

DEU shall initiate a collaborative process with the DPU and the OCS to develop a revised Clarification Letter to be sent to customers currently receiving third-party billing under Section 8.08;

...

Within 30 days after the date this order is issued, DEU shall either file with the PSC a clarification letter approved by the DPU and the OCS or inform the PSC that consensus was not reached



DEU has entered into a collaborative process with the DPU and the OCS and, together, those parties have developed two revised Clarification Letters, one to be sent to customers contracting for Gas Line Service and another for those customers contracting for Water Line Services. The Clarification Letter for Gas Line Service customers is attached as DEU Exhibit A and the Clarification Letter for Water Line Service customers is attached as DEU Exhibit B. DEU represents that the DPU and OCS have approved each letter.

DEU respectfully requests that the Commission accept the attached letters as being fully compliant with the ordering language referenced above, and provide DEU with authorization to send the letters to the referenced customers in the respective form attached.
