On November 2, 2018, Dominion Energy Utah (DEU) filed a Motion to Vacate the November 5, 2018 Hearing Date in this matter. DEU represented that DEU and Dustin Lance, the complainant, had reached a settlement agreement in principle and were working toward completing a final written settlement agreement. The same date, the Public Service Commission (PSC) issued an order granting the motion to vacate and directing the parties to file an update with the PSC by November 30, 2018 as to whether additional proceedings in this docket will be necessary.

On November 30, 2018, DEU filed a Joint Status Update representing the parties were "currently in the process of finalizing the Settlement Agreement" and that "[o]nce the Parties have completed the Agreement, a Joint Motion for Dismissal will be submitted for [PSC] review."

To date, the parties have made no additional filing. Inferring the parties settled the matter but failed to submit the agreement to the PSC, the PSC gives notice it intends to take no further action on Mr. Lance's complaint.
