On October 26, 2018, the Public Service Commission (“PSC”) issued an Order Granting Joint Motion to Extend Briefing Schedule in this docket. Consistent with that order, Dominion Energy Utah (“DEU”) filed its Response to Complaint of Brett Robinson and Brad Crookston (“Response”). On November 13, 2018, Complainants filed a Reply.

Having reviewed the Response and Reply, the PSC finds ambiguity exists as to whether and what issues remain to be resolved in this docket. The PSC, therefore, gives notice it will conduct a Status and Scheduling Conference on **Thursday, December 20, 2018 at 3:00 p.m., Fourth Floor Room 401**, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The parties should be prepared to discuss and identify with specificity what, if any, issues remain for the PSC to hear in this matter and any additional process they believe necessary for the PSC’s adjudication of such issues, including a suggested hearing date if a hearing is requested.

If it is more convenient for them, the PSC invites the parties to participate in the Status and Scheduling Conference by telephone. Participants attending by telephone should then call the bridge number five minutes before the conference, entering the passcode followed by the # sign to ensure participation.
