Formal Complaint of Scott M. Soulier against  
Dominion Energy Utah

REQUEST FOR ADDITIONAL BRIEFING

ISSUED: February 14, 2019

On December 7, 2018, Scott M. Soulier (“Complainant”) initiated this docket by filing a formal complaint (“Complaint”) against Dominion Energy Utah (“DEU”). On January 7, DEU filed a Response and Motion to Dismiss. On January 15, 2019, Complainant filed a reply (“Reply”), followed by additional correspondence on January 25, 2019.

In his Reply, Complainant asserts Utah Code Ann. § 54-3-3 required DEU to provide 30 days’ notice before closing the service station that is the subject of his Complaint.

Because the Complaint does not reference § 54-3-3, DEU has not had a reasonable opportunity to address Complainant’s argument on this point. The PSC prefers to understand DEU’s position on the matter before deciding DEU’s Motion to Dismiss or scheduling this matter for hearing. Accordingly, the PSC directs DEU to file a briefing on or before **Monday, March 18, 2019**, explaining whether DEU believes the notice requirements in § 54-3-3 apply to its closure of the service station at issue. Complainant may file a response on or before **Monday, April 1, 2019**.
