Pursuant to Utah Code Ann. § 54-4-1, and Utah Admin Code §§ R746-1-101 *et seq.* and R746-405-1 *et seq.* Questar Gas Company *dba* Dominion Energy Utah (Dominion Energy or Company) respectfully submits this Application to, change to Section 8.08 of the Company's Utah Natural Gas Tariff No. 500 (Tariff) to update the Company's third party billing rate, with an effective date of April 1, 2018.

On July 28, 2017, the Public Service Commission of Utah (Commission) issued an order in Docket No. 17-057-T04 approving the third-party billing rate. Section 8.08 of the Tariff explains how the third party billing rates are calculated. Specifically, this section states:

On or before March 1 of each year, the Company shall calculate the per-line rate and file a letter with the Commission reflecting the rate, to be effective on April 1 of each year. Accordingly, the Company has updated the calculation for the per-line rate for a minimum charge per bill and proposes to change the rate from \$0.16062 to \$0.16449. The Company also proposes to update the rate for all lines above eleven lines per bill from \$0.01460 to \$0.01495. See DEU Exhibit 1.1. The updated third-party billing rates have been incorporated into the legislative and proposed Section 8.08 of the Tariff attached as DEU Exhibit 1.2. At this time, no readily discernible market exists from which to derive a market price for billing for other entities. This proposed Tariff change does not constitute a violation of a state law or Commission rule.

THEREFORE, Dominion Energy respectfully, requests that the Commission:

1) approve the proposed Tariff change with an effective date of April 1, 2018, in accordance with its rules and procedures, and the Company's Tariff; and

2) approve the proposed rate.
