On August 1, 2018, Dominion Energy Utah (“Dominion”) filed an application with the Public Service Commission of Utah (“PSC”) requesting approval to modify sections of Dominion’s Utah Natural Gas Tariff No. 500 to provide clarity and specificity related to terms and conditions of transportation service.
