On August 10, 2018, Pacific Energy & Mining Company ("PEMC") filed a Motion to Request Reconsider [sic] Commission Order Dated August 9, 2018 and Request for Hearing ("Motion for Reconsideration"). The Public Service Commission ("PSC") gives notice it does not intend to grant the Motion for Reconsideration, which will, therefore, be denied by operation of statute 20 days after its filing. See Utah Code Ann. § 54-7-15(2)(c).

ORDER DENYING MOTIONS TO STAY AND INVITATION TO PROPOSE ALTERNATIVE HEARING DATE

On August 10, 2018, PEMC filed two separate motions to stay the proceedings (collectively, "Motions to Stay"). On August 20, 2018, the Division of Public Utilities ("DPU") filed a consolidated response to the Motion for Reconsideration and Motion to Stay. The DPU supports vacating the hearing date and rescheduling the hearing date to a time mutually convenient for the parties. The DPU represented in its response that it intended to confer with PEMC to agree upon such a date, but the parties have not yet provided the PSC with a proposed alternative date.

The PSC is not opposed to rescheduling the hearing but is disinclined to do so without setting an alternative date for the hearing. The Motions to Stay are, therefore, denied. To the

extent the parties believe the hearing should be continued, the PSC encourages the parties to file, jointly or otherwise, a request to continue the hearing with proposed alternative hearing dates. The PSC would also be happy to set the matter for a scheduling conference at the parties' request.
